

Tuition and Fees

The following tuition and the following fees are applicable for academic year 2020-2021:

Enrollment Fees (non-refundable)

New Student	\$200
Returning Student	\$150 (\$50 before March 1st)

Annual Tuition K2, K3, K4 (includes lunch)

4-5 full day all year*	\$7500
3 full day all year*	\$6000
4-5 half day all year*	\$6000
3 half day all year*	\$5000
4-5 full day following KCA calendar**	\$4500
4-5 ½ days or 3 full days following KCA calendar**	\$3500

*All year students include before and after care, holiday care, and summer care.

- Payment options are weekly, bi-weekly, or monthly.
- All Year – closed New Year's Eve, New Year's Day, Good Friday, Easter Monday, Memorial Day, July 4th, Labor Day, Thanksgiving (Thursday & Friday), Christmas Eve & Day, and 2 staff development days (TBD).

**KCA calendar students includes before and after care but follows the KCA school calendar (no holiday care or summer care)

Discounts:

- Multi-Child Discount
2nd Child – 20%, 3rd Child – 40%, 4th Child – 60%, 5th Child and Beyond– Free
Largest Discount will be applied to the Youngest Student's Tuition First
- Pastoral/Ministry, Veterans, Military, First Responders Discount (must show ID) = 10%

Payment Schedule Options

The following payment schedule options are applicable for academic year 2020-2021:

(A) One Payment Plan	Aug 1 (6% discount)
(B) Bi-Annual Payment Plan	Aug 1 & Jan 1 (3% Discount)
(C) 10 Payment Plan*	Aug 1 through May 1

PAYMENT DISCOUNTS DO NOT APPLY WITH ANY OTHER DISCOUNT

*Option C must be done with automatic withdrawals from checking or savings through the PraxiSchool system. With Option C, families may prepay their tuition balance at any time during the school year. Payments will be deducted on the 1st business day of each month. 10-month payments begin August 1st. KCA is a faith-based ministry which relies heavily upon the timely payment of its parents.

Payments in all plans are due in the office on the 1st of each month and a **late charge of \$25** may be applied to the account if payment is not received by the 15th of the month. If a tuition account becomes 60 days delinquent, the child or children may be removed from the school until the delinquent amount is paid in full or arrangements are made to pay. If arrangements are made and the agreed upon arrangements are broken, the child or children will be removed from school. In addition, report cards and transcripts may be withheld until full payment is rendered.

Financial Assistance

Renewanation Scholarship: KCA has been approved through Renewanation to offer scholarships through *Virginia's Education Improvement Scholarships Tax Credits Program*. This program allows individuals and corporations to take advantage of tax credits for their donations sent to Renewanation. These donations can then be leveraged by qualifying families and students that attend KCA. Applicants must complete the Family Application form in order to request scholarships for their student(s). Forms may be obtained in the office or online.

Painter Memorial Fund: Pastors, full-time ministers, veterans, first-responders, and KCA faculty and staff are offered financial assistance based on their ministry support or as a benefit of employment. For these assistance programs, other discounts will not be applicable.

Applying for Financial Assistance

Applications for financial assistance should be submitted no later than July 1st of each year. The following steps are applicable to applying for scholarships:

1. Complete the admissions process first as acceptance is not contingent upon financial need through FACTS.
2. Complete the application form through FACTS along with the requested documentation.
3. Applications will be sent to Renewanation for review. Scholarships will be awarded based on approval by Renewanation, the amount of funding available, and on an "as needed" basis. KCA will make every effort to award scholarship funds to all applicants that have been approved.

Re-enrollment

Re-enrollment for all current students of KCA begins on the first day of February. Re-enrollment fees are as follows:

- Prior to March 1st = \$50 per student
- After March 1st = \$150 per student

We acknowledge and agree that KCA reserves the right, at its sole discretion, to refuse to re-enroll or discontinue the enrollment of our child(ren) should a determination be made that we have failed to abide by the family agreement or are otherwise demonstrating an inability to cooperate with KCA. We acknowledge that continued enrollment is contingent upon our conduct, cooperation, and faithfulness to the mission of the school.

Withdrawal

In all cases of withdrawal, whether voluntary, involuntary, or otherwise, families are responsible for the entire month's tuition that withdrawal occurs and 50% of the remaining months of that semester. Tuition due and payable is calculated based on the percent of school year completed regardless of payment plan. If there is an outstanding tuition balance, transcripts and final report cards will be withheld until all payments have been reconciled.
